Green Room. Norma and I will be at Southport as it is one of the many theatres where I have been a member (one day I'll get one right!)



# THEATRE MANAGEMENT Safety

The Little Theatre Guild, of which we are a member, negotiated with the Society of London Theatre and UK Theatre to allow LTG members to apply for a 'See It Safely' mark in order to be able to

demonstrate that we are a Covid Secure Venue.



Though, at the moment, re-opening seems a distant prospect, we are working behind the scenes to ensure that we can open safely at the earliest opportunity.

#### Rostra

As you might know, on many occasions directors of plays in the Green Room have requested more than one level for staging. This always gives the set building team a challenge, as each platform takes some time to construct, as well as requiring the purchase of much material. As a result, we have recently purchased a set of lightweight rostra which will allow us to construct a variety of configurations quickly. These rostra have been supplied by the company from which we purchased the new seating, so the fittings are compatible with the variable seating rostra we already have.

The full cost of these new rostra has been provided by a generous grant from the Evans Trust, so has not diminished our own financial resources in these difficult times when our income is greatly reduced. We are therefore well set up and ready for future productions when we will be able to get back to what we all want to do, and produce plays in the Theatre again!

#### BUILDING PROJECT

I regret to have to inform members that Ian Cole has decided to step down as chairman of the Building Project committee. The early days (even years) of this project were dogged by difficulties with planning and it is entirely due to Ian's tenacity that we have a set of plans that have met with approval from the planners. We are in his debt. The committee is keen to appoint some new members and needs a new chairman. Anybody interested is asked to contact me or any member of the Executive.

The progress of the building will depend entirely on the rate at which we can raise funds. Approaches to external organisations for support have not been successful. We have commissioned and received a report from a professional fund-raising adviser which has given some avenues to explore. However it is apparent that the current circumstances are not conducive to large scale fund-raising. We are registered with www.easyfundraising.org.uk but currently only 16 members are signed up. Our top two supporters on this site have raised £100 between them - at no cost to themselves: you know who you are - thank you very much for running your purchasing through the site. If you are taking advantage of on-line shopping at the moment please consider accessing retailer sites via easyfundraising - there are about 4000 stores available so it's worth having a look. The fundraising report was clear that we should have a fundraising lead from within the society - this is an opportunity to make a real difference to the future of the theatre. To discuss further please contact me.

The committee is also considering whether there are any improvements that could be suitable for a 'crowdfunding' initiative rather than simply appealing for money for the larger project. Watch this space!



#### **RONNIE DYKSTRA -**

on his retirement as President

In 1977, twelve members of Styal Players joined the Green Room, amongst whom were Pat Barrow, Mike Janes, Mavis Carlisle and Ronnie Dykstra. Ronnie was immediately invited to join the Executive Committee, and what a foresighted idea that was! Over the years Ronnie,

supported by Sonia, has worked tirelessly on behalf of the Green Room, both on and off stage. His first stage appearance was in 1978 in Aladdin, when he played Ho Choo Choo, the Emperor of All China, and his most



recent was Joe Gates in **Tommy Boy** in 2016.

Fortunately he even managed to survive being hanged in the 1998 production of **Henry V** at Gawsworth, when the mechanism jammed, instead of preventing the noose from closing. Personally I thought he was taking Method Acting too far!

He has worked on Set Construction, been Stage Manager, Prompt, and on many occasions, House Manager. He was also on Team 2 of the Working Party involved in site clearance prior to the development of the premises, working every Saturday afternoon from November 1989 into 1990.

He was Chairman of the Society from 1992 -1993, and President from 2011 until 2020. He still continues to work in his unassuming manner, beavering away behind the scenes. His contribution to our Society is immense, and I would like to thank him, not only for myself, but also for all the members of the Wilmslow Green Room Society.

For each play one of the team would take 'the book', reading the script to establish the number of characters, the era, the number of changes, what the director has in mind and then taking the actors' measurements. Each of us works along with another member of the wardrobe team to make sure the outfits are assembled and, if necessary, we beg, borrow, buy or make any items to make the play more plausible.

During the production, Wardrobe members attend to help with hair, makeup, changes or even repairs.

When the production is over all items need to be cleaned, returned ... and then the next play starts rehearsal.
